Educator Plan Assignment

If you are in your **first, second, or third year** in the district, you will be assigned to a **Developing Educator Plan**.

If you are in your **fourth** year in the district, you will be assigned to **year one** of a two-year **Self-Directed Growth Plan**.

If in 2019-2020 you were assigned to **Year One of a Two-Year Self-Directed Growth Plan**, you will again be assigned to **Year One of a Two-Year Self-Directed Growth Plan**.

If in 2019-2020 you were assigned to a **Directed Growth Plan** you will discuss your specific situation with your Evaluator.

If in 2019-2020 you were assigned to a Two-Year Self-Directed Growth Plan the following will apply. If you were in Year One, you will again be assigned to Year One of a Two-Year Self-Directed Growth Plan. If you were in Year Two you will again be assigned to Year Two of a Two-Year Self-Directed Growth Plan. Educators assigned to these plans may continue with their same goals/plans and are not required to complete a new self-assessment unless they wish to rewrite their goals.

Observations

Educators in their **First** or **Second Year** on a **Developing Educator Plan** shall receive at least **one announced observation** and at least **four unannounced observations**.

Educators in their **Third Year** on a **Developing Educator Plan** may **request one** announced observation and shall receive at least **five unannounced observations**.

Educators on a **Directed Growth Plan** shall receive at least **five unannounced observations**.

Educators just receiving **Professional Teacher Status** and in the **First Year** of a **Two-Year Self-Directed Growth Plan** shall receive **three unannounced observations** in 2020-2021 and **two unannounced observations** in 2021-2022.

Educators returning to the **same self-directed growth plan** from **2019-2020** shall receive a **total** of **five unannounced observations** over the course of their plan. If an educator has received their **fifth unannounced observation already** no further unannounced observations shall occur through the duration of the plan.
